


Our Philosophy

Your Cat's Health: Ask the Vets at Cornell University

Q Is there a simple way to check my cats ears to see if they are healthy?

A Hearing is one of a cat's most important senses so keeping the ears healthy can

help painful infections from developing that could damage the ear canal or eardrum. Dermatologist William H. Miller, VMD at Cornell says the answer is as easy as stroking your pet. As you rub the ears you can easily notice of your cat shows signs of discomfort or extreme pleasure. Both instances are a clue that closer inspection is necessary. If there is pain or if the animal really gets into it and rubs his ears against your hand, there may be a problem. Other signs include bad odour, yawning, redness, frequent shaking of the head, scratching the ears, rubbing against furniture, tilting the head, or discharge of pus or dry brown wax. Healthy cats don't need their ears cleaned, but if they have had a history of ear problems, inspect them weekly. Keep your cats ears dry and clean, as bacteria and yeast thrive in moist warm environments. A trip to the vet for a professional ear exam may be necessary if you detect any of the symptoms above.



Note to Members

In early 2014, we will be engaging you in reviewing revised bylaws and purposes for the Victoria Cat Rescue Corps. The federal government has introduced changes for charities - the *Canada Not-for-profit Corporations Act* - that we need to follow to maintain our charity status. These include changing our bylaws to include some model bylaws developed for all charities and filing an application to continue our charity status. We need to have our bylaws and application approved by the federal government by October 17, 2014. As part of this process, we will review our purposes and bylaws to ensure they are up to date. Once we have a draft of the revised bylaws and application for continuance, we will ask for your feedback. When the final draft is complete, we will schedule a meeting of members to hold a vote. Once we have your approval, we will submit the documents to the federal government. Thanks in advance for helping us through this process.



Spotlight on Members—Tove Bording, Member & Volunteer



Growing up on a farm in Alberta where we had a variety of animals, from this daily contact grew my interest in and love of them. While studies and later my career in the Canadian diplomatic service kept me in cities, I missed having animals around. When stationed in Port of Spain, Trinidad, I acquired two dogs that I later brought to Canada. After this move they stopped getting along, so I found a home for one, but Scamp remained with me and accompanied me to assignments in various parts of the world. He finally ended his "diplomatic" days in Seattle at the age of 18. As a result of his

cremation at the Seattle Humane Society, I got involved with them on the fundraising side, where we tried a number of different activities to raise money. A really fun event was the dog washes; something entire families could participate in. Everyone ended up soaked to the skin but it was enjoyed by all—except maybe not the dogs!

On my return to Ottawa, I volunteered with Friends of Abandoned Pets (FOAP). My neighbours were cat people and had been feeding a family of feral cats in our back yards. There was a little black female kitten we named Mrs. Blackie. A cruel person kicked her and injured her very badly. At the animal hospital the prognosis was not very good, but this little cat survived. The bill however was over \$800, which FOAP covered. At this point it was decided that with such an investment, Mrs. Blackie should be renamed 'Treasure'. Later she came to my home to be nursed back to health, and thus I became a "Cat Person". I was also supposed to socialize her so we could place her in a good home, but she decided I was 'it' and she was my dear companion until she passed away at 14 years.

Treasure went with me to Los Angeles, my last posting, and when I returned to Victoria in1995, so did she. Both Scamp and Treasure sleep peacefully in my garden. Looking for volunteer possibilities, I found Victoria Cat Rescue (VCRCS) and have been a member, supporter and volunteer ever since. Unfortunately, I am no longer able to participate actively due to failing health, but thanks to the hard work and dedication of its members, the society soldiers on and will hopefully continue to do so.
